FURTHER INSTRUCTIONS

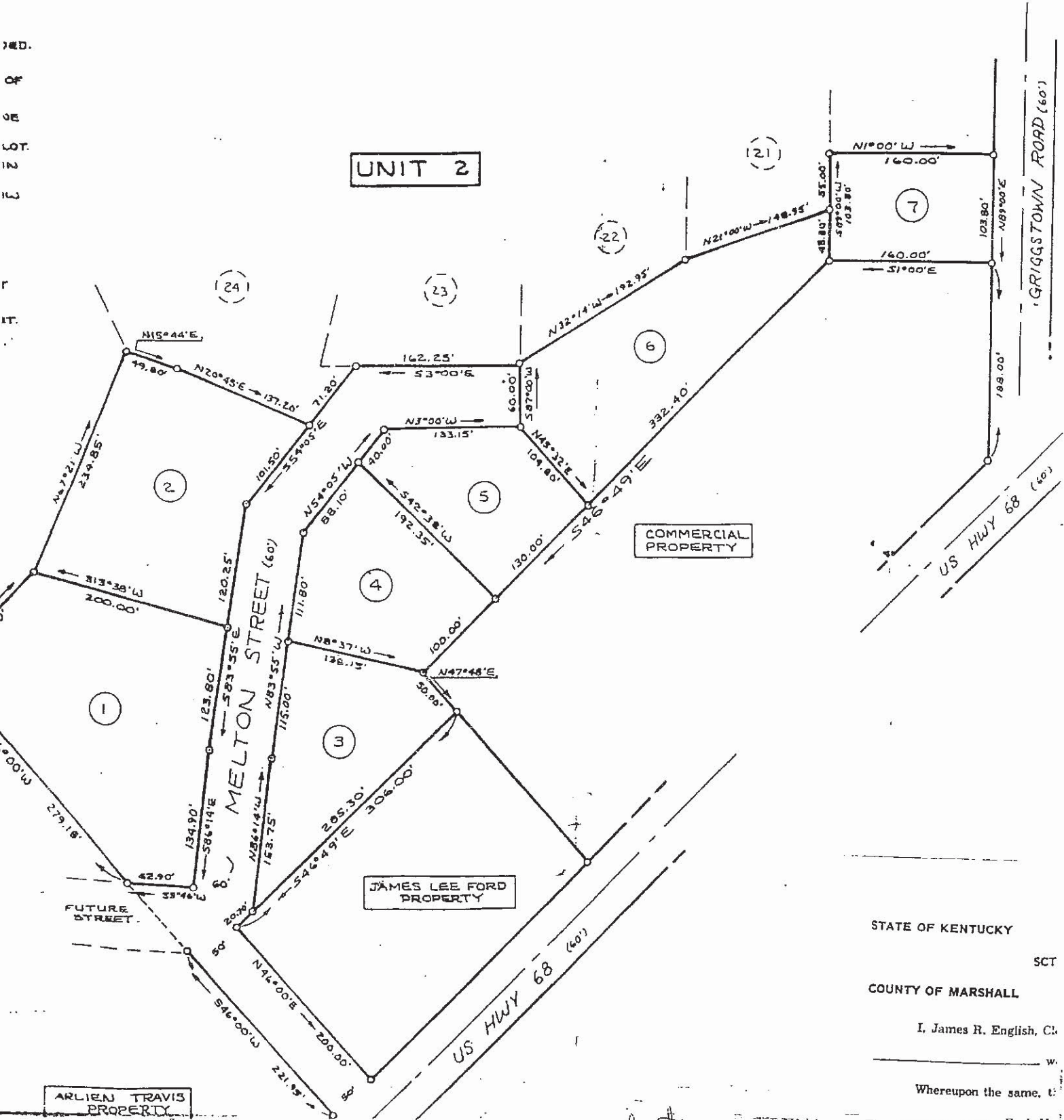
You are instructed further to provide to the Fiscal Court the following:

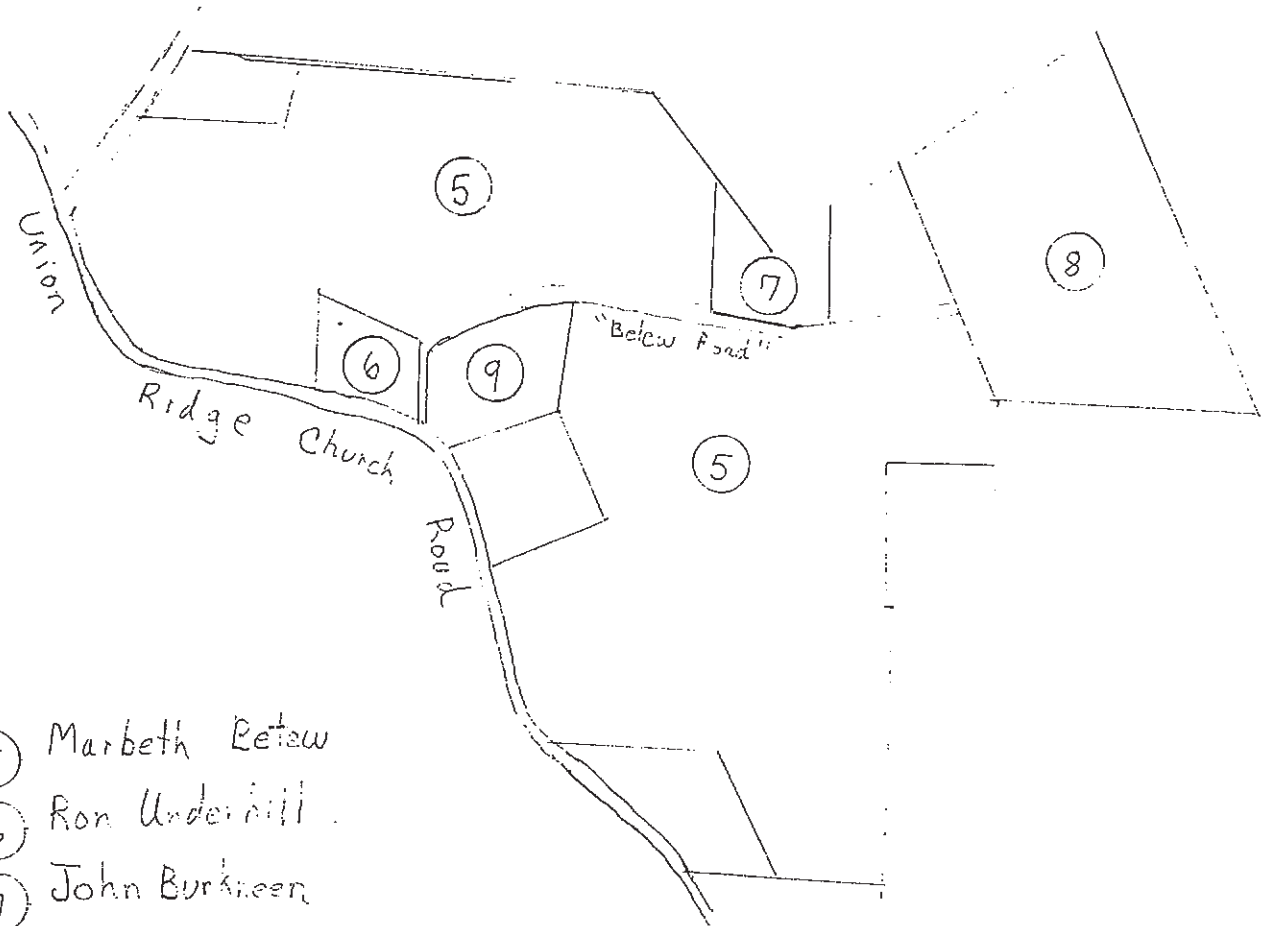

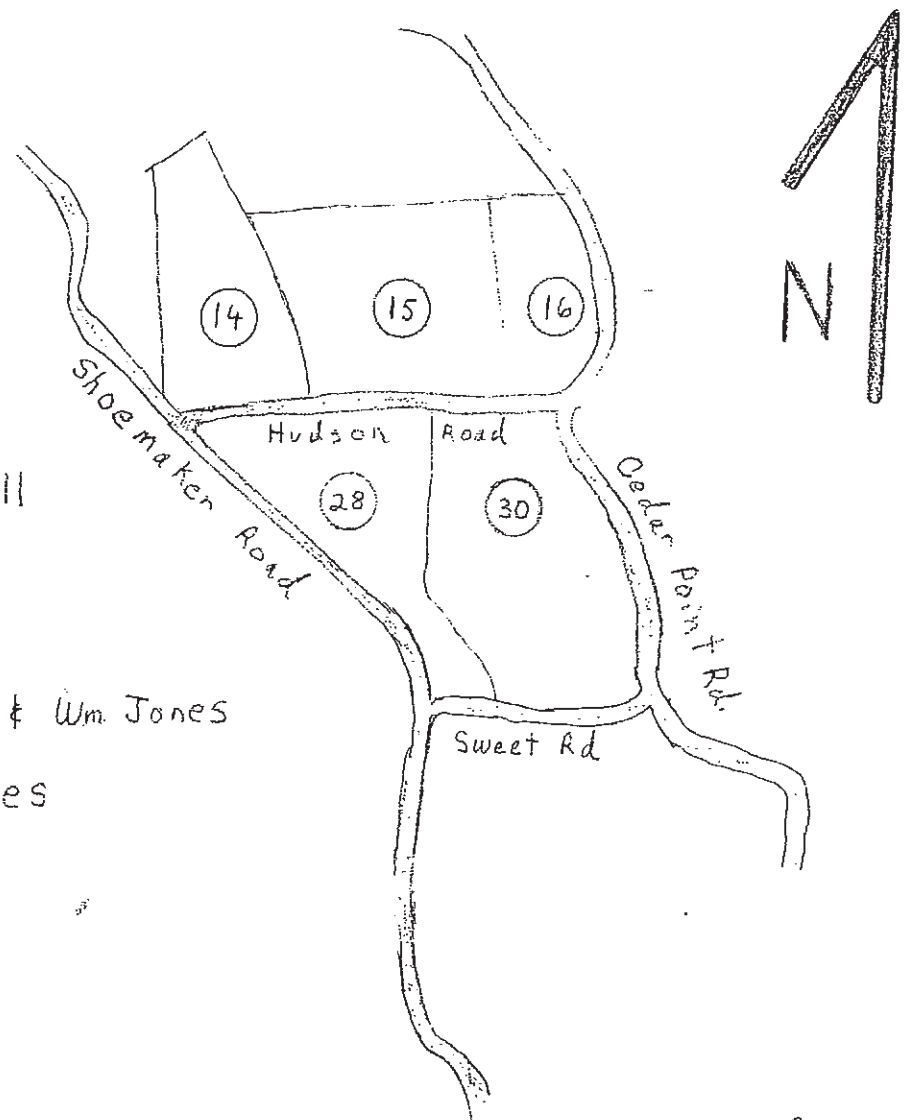
