

ANNEXATION AGREEMENT

WHEREAS, KRS 75.020 provides the procedure for annexation of territory by one fire protection district from another;

WHEREAS, Fairdealing-Olive Fire Protection District (FOFPD) does hereby wish to annex, with the consent of the Pioneer Fire Protection Association, Inc., (Pioneer) certain territory currently being serviced by the latter;

NOW THEREFORE, in accordance with the provisions of KRS 75.020, it is hereby understood and agreed as follows:

Pioneer does hereby consent to and grant over to FOFPD that territory on the west side of Tubbs Road extending north to Benton-Birmingham Road, then extending west to the south side of Benton-Birmingham Road to the Clarks River, to include the residents and territory on Wolfe Road.

IN RECOGNITION of the foregoing agreement, the fire chiefs and the respective boards of both FOFPD and Pioneer have hereinafter subscribed their names on this the 30th day of MARCH, 2018.

**PETITION FOR PROPOSED ANNEXATION OF TERRITORY BY THE

FROM THE PIONEER FIRE PROTECTION ASSOCIATION, INC.**


THE FAIRDEALING-OLIVE FIRE PROTECTION DISTRICT, WITH THE CONSENT OF THE PIONEER FIRE PROTECTION ASSOCIATION, INC., HEREBY PETITIONS AND PROPOSES TO ANNEX THE TERRITORY DESCRIBED IMMEDIATELY BELOW:

THAT TERRITORY ON THE WEST SIDE OF TUBBS ROAD EXTENDING NORTH TO BENTON-BIRMINGHAM ROAD, THEN EXTENDING WEST TO THE SOUTH SIDE OF BENTON-BIRMINGHAM ROAD TO THE CLARKS RIVER, TO INCLUDE THE RESIDENTS AND TERRITORY ON WOLFE ROAD.

ON May 1st at 0930, THE COUNTY-JUDGE EXECUTIVE SHALL, IF NO WRITTEN OBJECTION OR REMONSTRANCE IS INTERPOSED, ENTER AN ORDER ANNEXING THE TERRITORY DESCRIBED ABOVE.

FIFTY-ONE PERCENT (51%) OR MORE OF THE FREEHOLDERS OF THE TERRITORY SOUGHT TO BE ANNEXED MAY, AT ANY TIME BEFORE THE DATE FIXED IN THIS NOTICE, REMONSTRATE IN WRITING, FILED IN THE CLERK'S OFFICE, TO THE ACTION PROPOSED. IF SUCH WRITTEN REMONSTRANCE IS FILED, THE CLERK SHALL PROMPTLY GIVE NOTICE TO THE TRUSTEES OF THE FIRE PROTECTION DISTRICT, OR OF THE VOLUNTEER FIRE DEPARTMENT DISTRICT, AND THE COUNTY JUDGE/EXECUTIVE SHALL HEAR AND DETERMINE THE SAME.
