RESOLUTION

A RESOLUTION AUTHORIZING THE COUNTY JUDGE EXECUTIVE, KEVIN NEAL, ON BEHALF OF THE MARSHALL COUNTY FISCAL COURT, TO ENTER INTO A CONSORTIUM INTERLOCAL COOPERATION AGREEMENT PURSUANT TO KRS 65.210 ET. SEQ. BRINGING TOGETHER, BALLARD, CALDWELL, CALLOWAY, CARLISLE, CHRISTIAN, CRITTENDEN, FULTON, GRAVES, HICKMAN, HOPKINS, LIVINGSTON, LYON, MARSHALL, MCCRACKEN, MUHLENBERG, TODD AND TRIGG COUNTIES IN KENTUCKY, FOR THE PURPOSE OF ESTABLISHING THE PURCHASE/PENNYRILE WORKFORCE CONSORTIUM TO ADMINISTER EMPLOYMENT AND TRAINING PROGRAMS IN ACCORDANCE WITH THE WORKFORCE INNOVATION AND OPPORTUNITY ACT.

WHEREAS, the Workforce Innovation and Opportunity Act of 2014, Public Law, 113-128, as signed into law, July 22, 2014, provides Federal funds to state and local governments for programs designed to help job seekers access employment, education, training and support services to succeed in the labor market and to match employers with the skilled workers they need to compete in the global economy; and


WHEREAS, the Marshall County Fiscal Court recognizes that local workforce programs cannot be completely effected or implemented without intergovernmental coordination for the reason that such programs and their implementation cross governmental, departmental, and agency lines at the various levels of government; and

WHEREAS, the Fiscal Court desires to enter into a consortium agreement, pursuant to KRS 65.210 et. Seq., with the counties of Ballard, Caldwell, Calloway, Carlisle, Christian, Crittenden, Fulton, Graves, Hickman, Hopkins, Livingston, Lyon, Marshall, McCracken, Muhlenberg, Todd and Trigg for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE MARSHALL COUNTY FISCAL COURT:

Section 1. That the County Judge Executive, Kevin Neal, is hereby authorized to enter into and execute a consortium agreement pursuant to KRS 650.240 et. Seq. with the counties of Ballard, Caldwell, Calloway, Carlisle, Christian, Crittenden, Fulton, Graves, Hickman, Hopkins, Livingston, Lyon, Marshall, McCracken, Muhlenberg, Todd and Trigg, a copy of which is attached hereto and made a part of hereof, for the purpose of establishing the Purchase/Pennyrile Workforce Area Consortium to implement employment and training programs under the Workforce Innovation and Opportunity Act of 2014.

Section 2. This resolution shall take effect upon its passage and approval. This the 19th day of July 2022.
