

Marshall County Fiscal Court
February 7, 2023

The Marshall County Fiscal Court met for a regular meeting on Tuesday, February 7, 2023 at the Marshall County Courthouse, Benton, Kentucky. Elected Commissioners Eddie McGuire, Marty Barrett, Monti Collins, and County Attorney Jason Darnall were present. Judge Spraggs presided.

Judge Spraggs called court to order at 9:30 A.M.

I. GUESTS

A. A motion was made by Com. Collins and seconded by Com. McGuire to accept the former MC Clerk Tim York's Financial Settlement for the Calendar Year 2022 subject to audit. All voted aye. Motion carried.

B. A motion was made by Com. Collins and seconded by Com. McGuire to authorize County Clerk Crissy Greer to purchase ePollbook system for \$68,000, reimbursable by DLG. All voted aye. Motion carried.

C. Billy Pitts with the Marshall County Health Department updates the court on accomplishments for 2022 as well as plans for 2023 including strategic planning, Harm Reduction Programs, and model practice.

D. Judge Spraggs introduced Elizabeth Mudd, Kentucky Lake Economic Development Director and outlined her qualifications and achievements. Mrs. Mudd then addressed the court and highlighted some of her plans for the future of KLED.

A motion was made by Com. Barrett and seconded by Com. Collins to approve the bank transfer. All voted aye. Motion carried.


N. A motion was made by Com. McGuire and seconded by Com. Barrett to approve payment of the bills. All voted aye. Motion carried.
