Marshall County Fiscal Court March 21, 2023

The Marshall County Fiscal Court met for a regular meeting on Tuesday, March 21, 2023 at the Marshall County Courthouse, Benton, Kentucky. Elected Commissioners Eddie McGuire, Marty Barrett, Monti Collins, and County Attorney Jason Darnall were present. Judge Spraggs presided.

Judge Spraggs called court to order at 9:36 A.M.

I. <u>GUESTS</u>

- A. Chad McCann with Rivercrest Engineering updated the court on the Hardin and Oak Level water projects. A motion was made by Com. McGuire and seconded by Com. Barrett to approve eight Road Department Encroachment Permits and four State Application for Encroachment Permits for the Oak Level project. All voted aye. Motion carried. A motion was made by Com. Barrett and seconded by Com. McGuire to approve the cleaning of the water tank by Mid-South Consultants for \$4,250. All voted aye. Motion carried.
- B. EMS Director Bryan Cutsinger updated the court on the KOHS grants. A motion was made by Com. Barrett and seconded by Com. Collins to advertise for bids for the heart monitors. All voted aye. Motion carried. A motion was made by Com. Collins and seconded by Com. Barrett for Mr. Cutsinger to work with KOHS to change the scope of work on the grant for the radios. All voted aye. Motion carried.
- C. Parks Director Britney Hargrove updated the court on the lighting issues at Mike Miller park. 70 light in total need to be replaced. This will convert one soccer field and one baseball field to LED and is a long term cost savings. A motion was made by Com. Barrett and seconded by Com. Collins to advertise for bids for the light replacement at the park. All voted aye. Motion carried. Ms. Hargrove also stated that the Miracle League Gala fundraiser raised almost \$70,000.
