

Marshall County Fiscal Court
April 18, 2023

The Marshall County Fiscal Court met for a regular meeting on Tuesday, April 18, 2023 at the Marshall County Courthouse, Benton, Kentucky. Elected Commissioners Eddie McGuire, Marty Barrett, Monti Collins, and County Attorney Jason Darnall were present. Judge Spraggs presided.

Judge Spraggs called court to order at 9:30 A.M.

I. GUESTS

A. A motion was made by Com. Collins and seconded by Com. Barrett to approve the resolution for the EMS KOHS Grant. All voted aye. Motion carried.

II. CORRESPONDENCE

A. Deputy Judge Andrew Pagel read the March personnel changes as follows:

III. OLD BUSINESS

E. A motion was made by Com. Barrett and seconded by Com. McGuire to sign the Resolution Designating the Marshall County Industrial Development Authority as the SPGE for RDAAP Funds. All voted aye. Motion carried.

F. Treasurer Erica West read Ordinance 2023-07 Budget Amendment, first reading.
