The Marshall County Fiscal Court met for a Special Called meeting on Friday, June 30, 2023 at the Marshall County Courthouse, Benton, Kentucky. Elected Commissioners Eddie McGuire, Marty Barrett, Monti Collins, and County Attorney Jason Darnall were present. Judge Spraggs presided.


Judge Spraggs called court to order at 9:00 A.M.

- I. A motion was made by Com. Barrett and seconded by Com. McGuire to postpone this item until the next regular Fiscal Court meeting. All voted aye. Motion carried.
- II. A motion was made by Com. McGuire and seconded by Com. Barrett to reappoint Bobby Bradley to the Building Code Enforcement Board, term to expire 6/30/2026. All voted aye. Motion carried.
- III. A motion was made by Com. Collins and seconded by Com. Barrett to approve the purchase of a gradall for \$418,275 using excess carryover from the 2023 Road Department budget. All voted aye. Motion carried. A motion was made by Com. Barrett and seconded by Com. McGuire to purchase a mower for the Road Department, not to exceed \$10,000. All voted aye. Motion carried.
- IV. A motion was made by Com. Barrett and seconded by Com. McGuire to approve paving at Rocky Point Day Use Park not to exceed \$59,600 using funds intended for the first gradall payment that is no longer needed. All voted aye. Motion carried.
- V. A motion was made by Com. Barrett and seconded by Com. Collins to approve Road Department full time new hire Clayton Powell at \$21.08/hour effective 7/17/2023. All voted aye. Motion carried.
- VI. A motion was made by Com. Barrett and seconded by Com. McGuire to approve the estimate from Mid-South Tank for the repairs at the Oak Level Water Tower for \$22,700 with funds to come from ARPA. All voted aye. Motion carried.
- VII. A motion was made by Com. Barrett and seconded by Com. Collins to approve the Murtco change order for up to \$10,948 with funds to come from ARPA. All voted aye. Motion carried.
- VIII. A motion was made by Com. McGuire and seconded by Com. Barrett to approve the salary schedule effective 7/1/2023. All voted aye. Motion carried.
- IX. A motion was made by Com. and seconded by Com. to approve payment of the bills. All voted aye. Motion carried.
- X. A motion was made by Com. Collins and seconded by Com. Barrett to approve the appropriation transfer. All voted aye. Motion carried. A motion was made by Com. Collins and seconded by Com. Barrett to approve the bank transfer. All voted aye. Motion carried.
