1. The Petitioners herein, together with their names and addresses are:

2. The current road name is Lookout Lane.

3. The proposed name sought by the Petitioners is Beshears Lane.

4. The Petitioners have a recorded ownership interest in the land adjoining and/or abutting the county road at issue. (See Deeds recorded in Deed Book 336, page 115, Marshall County Court Clerk's Office and Deed Book 350, page 699, Marshall County Court Clerk's Office. Both of which are attached hereto.)

5. Five (5) of six (6) lot owners using Lookout Lane as their address support the change. A sixth lot owner has opposed this change in the past due to his use of this venue in rental advertising. However, the owner currently has his lot for sale and his current position is unknown. Notice of the Petition has been sent to his attorney.

See attached signatures supporting the change. Also see attached copies of deeds adjoining Lookout Lane.

6. The change in recognition that three (3) of the six (6) lots along Lookout Lane are owned by the Petitioners, the Beshears; and the other consenting lot owners acknowledge and recognize the Beshears' substantial ownership interest along the road. Most of the lot owners are


part-time residents and make no claim of permanency to the degree claimed by the Beshears. The name change is also sought to honor the Petitioner's father.



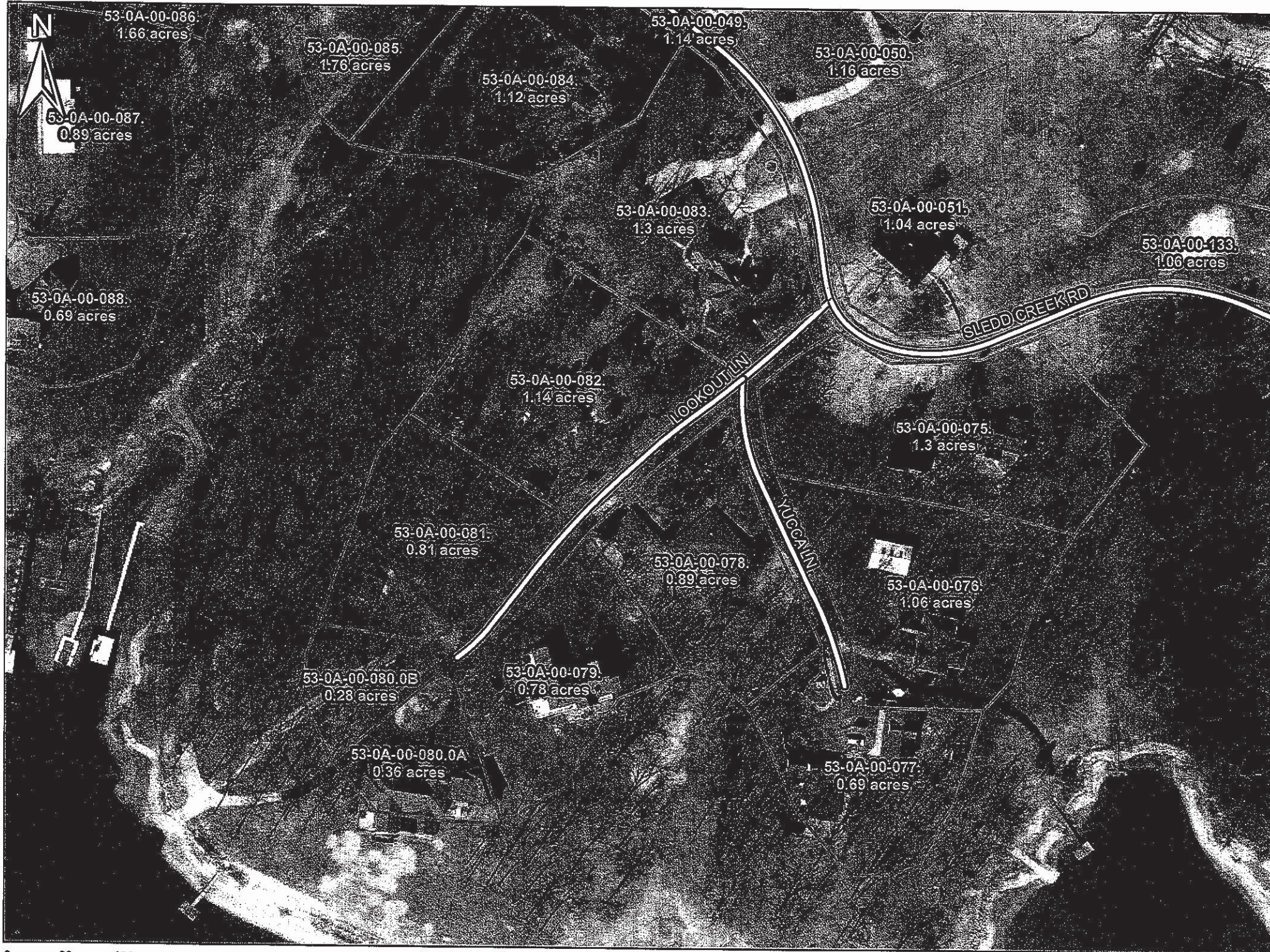

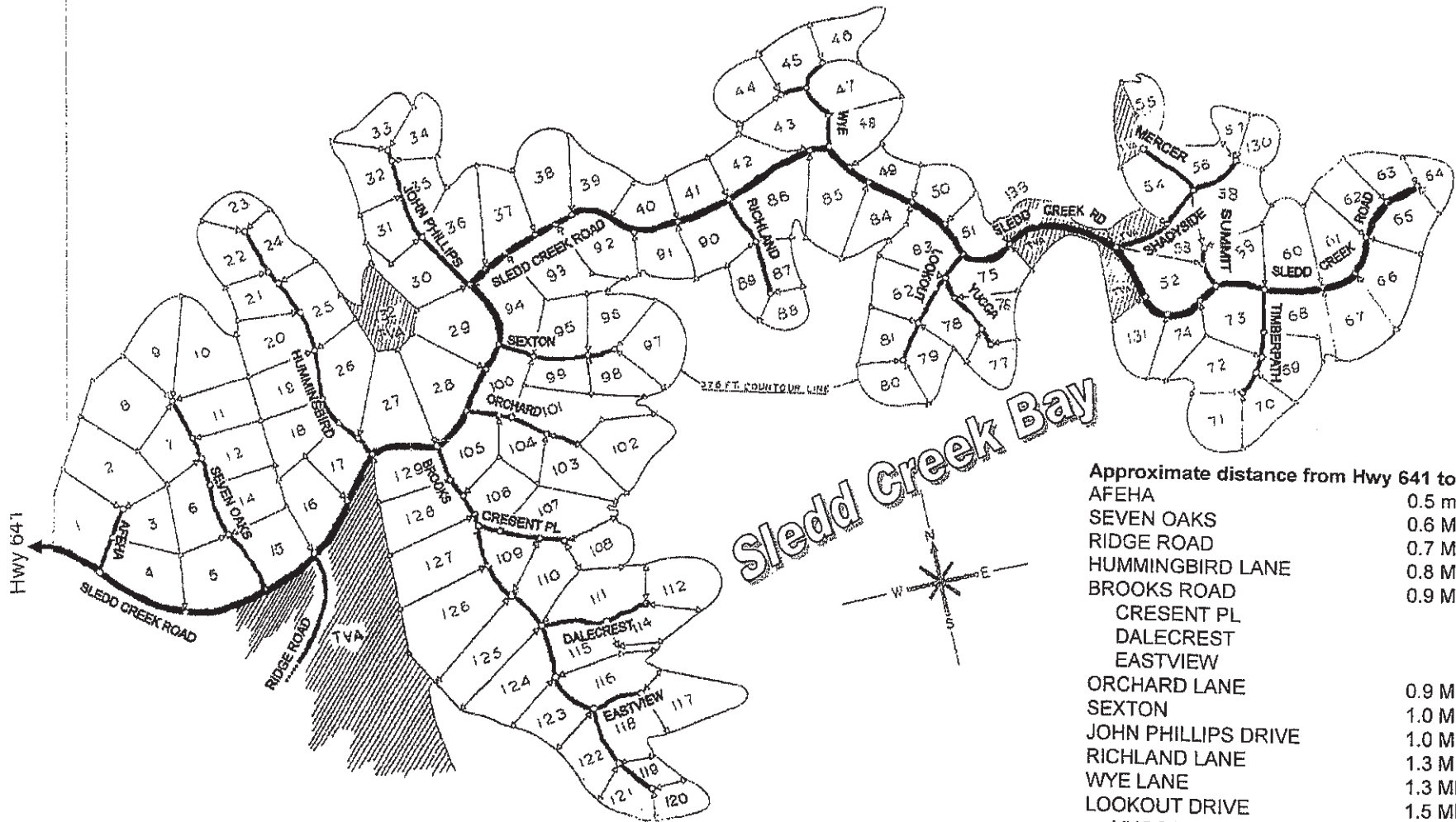
