RESOLUTION/ORDINANCE NO. 08-04

A RESOLUTION/ORDINANCE ESTABLISHING RESPONSIBLE BIDDER REQUIREMENTS FOR COUNTY CONSTRUCTION PROJECTS

WHEREAS, the Marshall County Fiscal Court does wish to ensure that its construction projects are handled by competent companies and individuals;

WHEREAS, the Marshall County Fiscal Court does wish to enact "Responsible Bidder" requirements;

NOW THEREFORE, BE IT RESOLVED/ORDAINED, by the Fiscal Court of Marshall County, Kentucky as follows:

Beginning September 16, 2008, any and all construction projects that are required to be bid by applicable law shall be subject to the following "Responsible Bidder" regulations. The Marshall County Fiscal Court shall reserve the right to summarily reject any and all bids and/or bidders that do not conform to the specifications and requirements of a "Responsible Bidder" as such term is defined below:

A Responsible Bidder for construction contracts means a bidder who meets all of the job specifications, the following applicable criteria, and submits sufficient evidence of compliance with same:

- (1) All applicable laws prerequisite to doing business in Kentucky.
- (2) Evidence of compliance with:
 - (a) Federal Employer Tax Identification Number or Social Security Number (for individuals)
 - (b) Provisions of Section 2000(e) of Chapter 21, Title 42 of the United States Code and Federal Executive Order No. 11246, as amended by Executive Order No. 11375 (known as the Equal Opportunity Employer provisions).
- (3) Certificates of insurance indicating the following coverages: general liability, workers' compensation, completed operations, automobile, hazardous occupation, and product liability;
- (4) The bidder and all bidder's sub-contractors must participate in active apprenticeship and training programs approved and registered with the United States Department of Labor's Bureau of Apprenticeship and Training for each of the trades of work completed under the awarded contract;

(5) All contractors and sub-contractors are required to turn in certified payrolls.

The Marshall County Fiscal Court met in regular session on Tuesday, August 19, 2008 in the Joe Williams Fiscal Courtroom, Marshall County Courthouse, Benton, Kentucky. All duly elected Commissioners and Assistant County Attorney Jason Darnall were present. Mike Miller, County Judge/Executive presided.

I <u>GUESTS</u>:

- A. Debbie Allen with the JDSM Nursing Scholarship Foundation addressed the Court regarding the September 12th 14th "Run for Nurses" Motorcycle Ride & Music Festival. The fundraising event is being held at Inn by the Lakes and Ms. Allen asked for the Court's help. Money raised provides scholarships to nursing students. The county will help by providing picnic tables.
- B. Sheriff Kevin Byars informed that the annual Sheriff's Ranch Golf tournament will be held at Marvel Golf Course on September 20th.
- C. Sheriff Byars presented a Resolution for the Court's consideration which authorizes Judge Miller to make application for and, upon approval, to enter into an agreement with the Kentucky Office of Homeland Security to execute any documents which are deemed necessary to facilitate and administer a grant project for communication equipment. A motion was made by Com. Anderson and seconded by Com. Gold to approve the Resolution as presented. All voted aye. Motion carried.
- D. Sheriff Byars asked for the Court's consideration of purchasing a used 2004 police interceptor, which has approximately \$10,000 worth of electronic equipment compatible with that used by Marshall County. The total cost for the vehicle is \$15,900.00. A motion was made by Com. Anderson and seconded by Com. Gold to purchase the vehicle as requested. All voted aye. Motion carried.
- E. Bobby Gifford, Director of Water Vision 2020 presented a request for payment for WX21157046 in the amount of \$117,397.50. A motion was made by Com. Anderson and seconded by Com. Gold to approve payment. All voted aye. Motion carried.
- F. Judge Miller informed that the \$1.8 million which was approved for Phase II of Water Vision 2020 by the General Assembly will not be available until January and presented documentation for the Court's consideration for a short term loan through KACo. The documentation included a Resolution, Notification of Intent to Lease, and a Public Hearing Notice. A motion was made by Com. Anderson and seconded by Com. English to approve the Resolution as

presented. All voted aye. Motion carried. The Public Hearing was scheduled for 11:00 a.m. on Tuesday, September 16, 2008.

- B. Haven of Hope sent a letter regarding their annual banquet. The Court has purchased a table in the past. A motion was made by Com. English and seconded by Com. Gold to purchase a table again this year. All voted aye. Motion carried.
- C. Ken Mitchell, Executive Director of the Kentucky Office of the 911 Coordinator/CMRS Board informed that the 2007 CMRS Grant in the amount of \$24,101 for Marshall County has been successfully completed and is now officially closed. Judge Miller thanked Marshall County 911 Director Marshall Penney for a job well done.
- D. Myralee Smith-Cowley, Executive Director, Office of Federal Grants, Governor's Office for Local Development, informed that the Marshall County Water Spray Pad Project was not selected for funding. Judge Miller added that of the 120 applications, only seven will receive funding.
- E. Jailer Roger Ford informed that the items of non-compliance noted during the recent jail inspection have been corrected.
- F. Shirley Johnson, Producer and Director of Twilight Cabaret sent a letter of appreciation for the Court's recent contribution.
- G. Terry Blackwell, CEO of the Girl Scouts of Kentuckiana sent a letter of appreciation for the Court's recent contribution.
- H. Lena Mallory, County Extension Agent for 4-H Youth Development sent a letter of appreciation for the Court's recent contribution.
- I. A motion was made by Com. Gold and seconded by Com. English to sponsor the Storytellers/Writers/Poets Workshop which is scheduled for three

consecutive weekends at the Marshall County Library. All voted aye. Motion carried. (The cost for the sponsorship is \$550.00.)

III. OLD BUSINESS:

- A. A motion was made by Com. English and seconded by Com. Gold to approve the minutes of the July 15th meeting. All voted aye. Motion carried.
- B. Discussion was held about the purchase of land adjacent to the county park. This item was tabled.
- C. Marshall County Sanitation District #1 informed that road department was widening KOA Lane in Aurora and damaged two sewer mains. The total bill for repairs, parts, and labor is \$784.57. A motion was made by Com. Gold and seconded by Com. Anderson to pay the District for the damages. All voted aye. Motion carried.
- D. Troy Kirkendall, Superintendent of Parks, asked for the Court's consideration of declaring the following items as surplus property:

- C. Several weeks ago action was tabled regarding a proposed Ordinance for Responsible Bidders. Since that time, the County Attorney has reviewed the document and it is ready for the first reading. Following the first reading, a motion was made by Com. English and seconded by Com. Anderson to approve the first reading of Ordinance #08-04. All voted aye. Motion carried. (See item L, page 5.)
- D. Following the second reading of Ordinance #08-02 (off site auto displays), a motion was made by Com. English and seconded by Com. Anderson to approve the second reading and adopt Ordinance #08-02. All voted aye. Motion carried.
- E. Judge Miller informed that the West Kentucky Allied Services Report is on file in his office for public review.
- F. Copies of the County Clerk's Audit were distributed and are also on file in the County Judge/Executive's Office.
- G. Following the first reading of Ordinance #08-03 (tax rates), a motion was made by Com. English and seconded by Com. Gold to approve the first reading. All voted aye. Motion carried.
- H. The 2006/07 Audit of the Marshall County Library is on file in the County Judge/Executive's Office for public review.

- I. A motion was made by Com. Gold and seconded by Com. Anderson to approve the Treasurer's Report, subject to audit. All voted aye. Motion carried.
- J. A bid opening was held August 5th for the purchase of a new multipurpose rescue truck for the Ambulance Service. Advertisement for bids was published in the July 22nd edition of the <u>Tribune Courier</u>. Ambulance Service Director Mark Harrison, Ambulance Service employee Mark Combs, and Marshall County Finance Officer Emily Martin opened the bids. Three companies responded:
 - 1. Fire Apparatus Division S.D.C. of Louisville, Kentucky submitted a "no bid" response.
 - 2. Emergency Vehicle, Inc. of Lake Park, Florida \$152,872.00 on a 2009 Ford F-550 4-door (extended) super Cab/EVI 12-ft. non-walk-in.
 - 3. Wynn Fire Equipment of Corbin, Kentucky \$144,950.00 on a 2008 Ford F550 Extended Cab 2-door.

Both bids included an air cascade system, which provides the means to re-fill oxygen tanks. Following discussion, a motion was made by Com. Anderson and seconded by Com. All duly elected Commissioners, the County Attorney, and Assistant County Attorney were present. Mike Miller, County Judge/Executive presided.

I. GUESTS:

- A. Gene Gilliland, representing Renaissance on Main Street, asked for the Court's consideration of contributing \$300.00 to go toward purchasing pumpkins and supplies for the Autumn Jubilee on October 25th. A motion was made by Com. English and seconded by Com. Anderson to contribute \$300.00 as requested. All voted aye. Motion carried.
- B. Members of the Marshall County Arts Commission were present and Judge Miller read a Proclamation naming October "Arts and Humanities Month" in Marshall County. A motion was made by Com. Discussion was held about cost being up to \$200,000 the plans for the turn lane will not be available until September 18th and an estimate can actually be obtained after receiving those plans. Judge Miller added that he has been told the hospital project will not move forward without this turn lane. Judge Miller read the Agreement for the Court's consideration. - G. County Attorney Jeff Edwards said he has been told that the Marshall County Hospital Board will be putting the old hospital property for sale this evening.
- H. A motion was made by Com. Anderson and seconded by Com. English to go into executive session to discuss personnel. All voted aye. Motion carried.
 - I. Judge Miller called Court back into regular session.
- J. A motion was made by Com. English and seconded by Com. Anderson to recess for a scheduled public hearing regarding a short-term funding program through KACo for Water Vision 2020.
 - K. Judge Miller called Court back into regular session.
- L. A motion was made by Com. Gold and seconded by Com. Anderson to enter into an agreement for short-term funding through KACo for Water Vision 2020. All voted aye. Motion carried.
- M. Judge Miller informed that discussion was held during executive session about changes in Hazardous Duty Retirement which became effective September 1st. County Attorney Jeff Edwards read a Resolution for the Court's consideration for an agency transferring from Non-Hazardous to Hazardous

The Marshall County Fiscal Court shall reserve the right to summarily reject any and all bids, and/or bidders that do not conform to the specifications and requirements. je of this Ordinance, any and all constructo and/or bidders that do not conform to the specifications are of a "Responsible Bidder," as such term is defined below:

- A Flesponsible Bidder for construction contracts meens a bidder who meets all of the job specifications, the following applicable criteria, and submits sufficient evidence of compliance with same:

- (4) The bidder and all bidder's sub-contractors must participate in an live appendicability and training programs approved and registered with the United States Department of Labor's Bureau of Apprenticaship and Training for each of the trades of work completed under the awarded
- payrolis.
