

ORDINANCE

95-C5

AN ORDINANCE PURSUANT TO KRS 65.182, THE CREATION OF THE SPECIAL TAXING DISTRICT, KNOWN AS THE HARVEY/BREWERS VOLUNTEER FIRE DEPARTMENT AND THE FIXING OF THE BOUNDARIES AND AD VALOREM PROPERTY TAX.

Be it ordained and enacted by the Fiscal Court by the county of Marshall, Commonwealth of Kentucky; that:

1. On February 21, 1995, a petition was submitted and accepted by the Marshall County Fiscal Court to hold a public hearing to determine whether there is justification for the formation of a special taxing district for Harvey/Brewers Volunteer Fire Department. The public hearing was set for April 4, 1995 at 11:00 A.M.

2. After advertisement in the Tribune Courier, a public hearing was held on April 4, 1995 at 11:00 A.M. Marshall County Judge/Executive, Mike Miller, gave the opportunity to everyone in opposition or in favor of said petition to speak.

3. On April 18, 1995, the Marshall County Fiscal Court voted to grant a special taxing district to Harvey/Brewers Fire Department.

Therefore, be it further ordained and enacted by the Fiscal Court of the County of Marshall, Commonwealth of Kentucky that:

4. The following area shall be designated as the Harvey/Brewers Volunteer Fire Department:

Using the 911 Area Map distributed by the Marshall County Sheriff Department, we, the Harvey/Brewers Volunteer Fire District Board of Directors, wish to present the following area to be designated as the Harvey/Brewers Volunteer District:

Using the Harvey/Brewers Fire Station on Hwy58, (Mayfield Hwy) in Harvey, as a starting point, go in a northeasterly direction up Hwy 58 to address 4376 (west side of Mayfield Hwy) and address 4401 (east side of Mayfield Hwy); then in a northwesterly direction to Cole Cemetery Road, taking all addresses 400 and above (Leroy

Lyles 338); continuing northwesterly to the Houser Road just past address 1096 Houser Road (Anna Lou Darnell); then north by northwest to the bridge on Middle Fork Creek on Hwy 408 (Oak Level Road); then west on Hwy 408 to the intersection of Hwy 1949, then in a northwesterly direction to the Gatlin Road; then in a southwesterly direction to the intersection of the Graves County line and the Van Pitt Road; follow the Graves County line south to the Calloway County line; then left or east following the Calloway County line to Hwy 1311 (Slickback Road); the intersection of the Covington Road, turning right or east on Covington Road (serving the north side only) then turning left or north at first curve, (serving the west side only) continuing north until second curve, at this point turning west to the East property line of Dallas Dowdy, and north (following the property line) to the Dowdy Cemetery Road; then left or west on Dowdy Cemetery Road; then at the intersection where Dowdy Cemetery Road and Hwy 1311 (Slickback Road) run concurrent for approximately one half mile (serving the left or south side only); then continuing North on Hwy 1311 to the intersection of Dallas Lane (serving Dallas Lane), then in a southwesterly direction to the north side of 4057 Jackson School Road (Glen King residence); then in a westerly direction to Hwy 58 at addresses 4376 and 4401 Mayfield Hwy, then back to starting point.

5. Pursuant to the Petition filed the ad valorem tax to be levied to all tax bills within this particular district of the county shall be at a rate of 7.5 cents per \$100.00 assessed value.

6. The creation of the Harvey/Brewers Volunteer Fire Department special taxing district shall be of legal effect upon the adoption of this Ordinance in accordance with provisions of KRS 67.075 and KRS 67.077, and compliance with the requirements of KRS 65.005.

7. A Certified Copy of this Ordinance creating the Harvey/Brewers Fire Department Special Taxing District shall be filed with the County Clerk who shall add the levy to the tax bills of the county. For taxing purposes, the effective date of the tax levy shall be January 1, 1996, which is the year following the certification of the creation of the special taxing district.

8. Nothing in this Ordinance shall be construed to enlarge upon or to restrict the powers granted to a Special Taxing District under the taxing district specific authorizing statutes.
