

ORDINANCE 07-07

**AN ORDINANCE DECLARING AND ESTABLISHING
THE ELECTRONIC INDEXES IN THE
MARSHALL COUNTY COURT CLERK'S OFFICE
AS THE OFFICIAL LAND RECORD
INDEXES OF MARSHALL COUNTY**

Whereas, the Marshall County Court Clerk is the custodian of all land records for Marshall County, Kentucky, and is charged with the responsibility of keeping and maintaining a proper index for all land records maintained in that office, and

Whereas, the Marshall County Clerk is utilizing computers to index the land records for Marshall County for all filings from and after a period that commences January 1, 1982 ("electronic index"); and


Whereas the Marshall County Court Clerk's Office also maintains a written record of those transactions that are contained in the computerized index ("written index") and the maintenance of two (2) separate sets of indexes makes it necessary for the Fiscal Court to establish one of those indexes the Clerk maintains as the official Marshall County Land Record Index.

Now Therefore it is ordained that:

1. This ordinance may be cited as the official designation of the Electronic Indexes for Marshall County, Kentucky.
2. The Marshall County Court Clerk may use computers and electronic word processing programs and electronic equipment to keep the land records in that office and to organize same in indexes for purposes of retrieval and review. Such computerized records and electronic indexes shall be the official records in that office but shall be substituted for written

records that the Clerk is required by Local, State, and Federal law to keep. The Clerk shall continue to maintain in writing such original ordinances, resolutions, orders and other matters filed in that office but the official index for all such records shall be the electronic indexes the Clerk has established in that office pursuant to this ordinance.
