# Marshall County Fiscal Court January 8, 2019

The Marshall County Fiscal Court met in regular session on Tuesday, January 8, 2019 in the Fiscal Courtroom, Marshall County Courthouse, Benton, Kentucky. Elected Commissioners: Justin Lamb, Kevin Spraggs, Monti Collins, County Attorney Jason Darnall and Assistant County Attorney Jacob Ford were present. Kevin Neal, County Judge/Executive presided.

## I. GUESTS

A. Marshall County Clerk Tim York presented his 2019 Budget and 2019 Order Setting Maximum Amount for Deputies and Assistants. A motion was made by Com. Lamb and seconded by Com. Collins to accept the Clerk's 2019 Budget. All voted aye. Motion carried.

A motion was made by Com. Spraggs and seconded by Com. Lamb to accept the Clerk's 2019 Deputy Hire. All voted aye. Motion carried.

B. Chad McCann with Rivercrest Engineering presented a draw down request for Murtco's work on the Sanitation District expansion in the amount of \$238,581.32. A motion was made by Com. Collins and seconded by Com. Spraggs to approve the draw down request. All voted aye. Motion carried.

Jonathan Smith with Marshall County Sanitation District gave an update on the sanitation plant at Draffenville. Mr. Smith stated new usage rate letters went out this week, if customers have questions or comments regarding the rate changes they should bring those to the Sanitation board meeting on January 23<sup>rd</sup> at the Aurora Fire Station at 4:30 PM.

The bid advertisement requested bids for a sedan police vehicle and a pickup truck. There was only one bid from Parkway Chrysler for a 2019 Dodge Charger Pursuit AWD in the amount of \$25,519.00. Judge Neal stated the procurement process was followed correctly, the court just needed to accept the bid so Sheriff McGuire can pay for the vehicles. A motion was made by Com. Collins and seconded by Com. Spraggs to accept the bid from Parkway Chrysler and to purchase two 2019 Dodge Charger's at that same price. All voted aye. Motion carried. Sheriff McGuire stated he cancelled the order for the pickup truck.
- F. A motion was made by Com. Lamb and seconded by Com. Collins to approve the employment status change for Maranda Hanson from part-time to full-time effective 01/08/2019. All voted aye. Motion carried.
