

Marshall County Fiscal Court  
March 17, 2020

The Marshall County Fiscal Court met in regular session on Tuesday, March 17, 2020 at the Marshall County Courthouse, Benton, Kentucky. Elected Commissioners: Justin Lamb, Kevin Spraggs, Monti Collins, County Attorney Jason Darnall were present. Kevin Neal, County Judge/Executive presided.

I. GUESTS

A. EMS Director Bryan Cutsinger addressed the court regarding a grant opening with the Kentucky Department of Homeland Security. Mr. Cutsinger would like to apply for this grant to purchase four new chest compression systems totaling \$63,702. This is a reimbursement grant. A motion was made by Com. Lamb and seconded by Com. Collins to approve applying for the grant. All voted aye. Motion carried.

B. Marshall County Health Department Director Billy Pitts updated the court regarding the COVID-19 virus. He stated that the state website is being updated continuously throughout the day with data and resources. He also outlined the requirements for testing, number of cases, action plans and Marshall County's response team responsibilities.

C. A motion was made by Com. Lamb and seconded by Com. Collins to approve Special Projects new hire Dustin Tillson at \$16 per hour effective immediately. All voted aye. Motion carried.

D. A motion was made by Com. Collins and seconded by Com. Spraggs to approve Road Superintendent Wendy Greer to hire three seasonal part time employees at \$12 per hour. All voted aye. Motion carried.

E. A motion was made by Com. Collins and seconded by Com. Lamb to approve the appropriation transfer. All voted aye. Motion carried.

F. A motion was made by Com. Lamb and seconded by Com. Collins to approve payment of the bills. All voted aye. Motion carried.
