## Marshall County Fiscal Court October 6, 2020

The Marshall County Fiscal Court met in regular session on Tuesday, October 6, 2020 at the Marshall County Courthouse, Benton, Kentucky. Elected Commissioners: Justin Lamb, Kevin Spraggs, Monti Collins, County Attorney Jason Darnall were present. Kevin Neal, County Judge/Executive presided.

Judge Neal called court to order at 9:35 AM.

### I. GUESTS

- A. DJ Story with Peel & Holland presented the health insurance rates for next year. A motion was made by Com. Collins and seconded by Com. Spraggs to approve and sign the Benefit Advisory Services Agreement with Peel & Holland. All voted aye. Motion carried.
- B. Tammy Blackwell with the Marshall County Public Library presented the Library's Annual Report for fiscal year 2019-2020.
- C. David Culp addressed the court regarding noise complaints with local businesses. Mr. Culp pointed out several parts of Ordinance #2015-05 that pertain to interfering with residents. County Attorney Jason Darnall explained the issues with those parts of the Ordinance and enforcement or proof of wrongdoing. Mr. Culp has sent several videos to the Commissioners and County Attorney documenting the excessive noise levels at his residence. There was lengthy discussion about possible ways to resolve the issue. Sheri Swatzell, owner of the Dam Brewhaus addressed the court regarding the measures they are taking to work with neighbors to resolve the issues.

- C. A motion was made by Com. Collins and seconded by Com. Lamb to deny the bid from Minter roofing to repair the courthouse roof. All voted aye. Motion carried. A motion was made by Com. Lamb and seconded by Com. Collins to move forward with finding an architect to investigate and make recommendations regarding the repair of the courthouse roof. All voted aye. Motion carried.
- D. A motion was made by Com. Collins and seconded by Com. Spraggs to accept Commodore Lane into the County Road Maintenance System contingent upon final road surfacing. All voted aye. Motion carried.
- E. There was discussion regarding the project options Draffenville Sewer Expansion Project including project cost, bond monies remaining, and number of homeowners that could potentially benefit from each option. A motion was made by Com. Collins and seconded by Com. Lamb to approve Alternates A and B from Rivercrest Engineering for the West Sewer Expansion Project. Judge Neal voted yes, Com. Lamb voted yes, Com. Collins voted yes. Com. Spraggs voted no. Motion carried.

- A. A motion was made by Com. Lamb and seconded by Com. Collins to appoint Jeff Russell to the Marshall County Sanitation District Board to fill the vacated term of Ricky Sirls to expire 1/1/2021. All voted aye. Motion carried.
- B. A motion was made by Com. Lamb and seconded by Com. Collins to approve Rachel Opiola promotion to Dispatch Supervisor. All voted aye. Motion carried. A motion was made by Com. Lamb and seconded by Com. Collins to approve Jamey Spears change to full-time status. All voted aye. Motion carried.
- C. Deputy Judge Brad Warning read the bid advertisements for bid that were published in the Tribune Courier on September 22, 2020 for an ambulance remount and powerload system. He then opened and read the bids. A motion was made by Com. Lamb and seconded by Com Collins to table the item. All voted aye. Motion carried.
- D. A petition was submitted by the residents that live on Soldier Creek to expand the Jonathan Creek water project to their road. A motion was made by Com. Lamb and seconded by Judge Neal to include Soldier Creek Road in the Jonathan Creek Water Project. All voted aye. Motion carried.

- F. Judge Neal appointed Andy Lepisto and Brad Warning to complete a road review of Walton Lane. A Public hearing regarding removing a section of Walton lane from the County Road Maintenance System was scheduled for October 20, 2020 at approximately 10:00 AM.
- G. A motion was made by Com. Collins and seconded by Com. Lamb to sign the Proclamation declaring October 12 through October 18, 2020 Family Week in Marshall County. All voted aye. Motion carried.
- H. A motion was made by Com. Lamb and seconded by Com. Collins to retrieve the ambulance bid item from the table. A motion was made by Com. Lamb and seconded by Com. Spraggs to accept EMS Director Bryan Cutsinger's recommendations to accept the Stryker bid for \$21,070 for a Powerload system and the Select Tech bid for \$97,266 for the ambulance remount. All voted aye. Motion carried.
- I. A motion was made by Com. Collins and seconded by Com. Spraggs to approve the interfund transfer. All voted aye. Motion carried.
- J. Judge Neal asked if there was any reason to deny bills and claims. The bills and claims are to be paid.
