EMERGENCY EXECUTIVE ORDER NOVEMBER 23, 2020

WHEREAS, on November 18, 2020, the Governor of the Commonwealth of Kentucky, Andy Beshear, issued an Executive Order pertaining to, among other things, restaurant operations, due to the rising confirmed cases of COVID-19; and

WHEREAS, local government has the responsibility to protect the public health, safety and welfare, and to mitigate the effects of such events;

WHEREAS, the Marshall County Fiscal Court has a vested interest in seeing that restaurant operations continue as normally as possible due to payroll and restaurant tax revenue;

NOW, THEREFORE, I, Kevin Neal, Marshall County County Judge/Executive, by the authority vested in me by KRS 39A.100(2), do hereby issue this Emergency Executive Order and direct as follows:

- 1. The Marshall County Fiscal Court will provide certain items of personal property in its discretion to restaurants to facilitate outdoor dining options.
- 2. The items will be made available under terms and conditions as set forth in a Conditional Use Permit incorporated into this Order and attached hereto.
- 3. All restaurants who request such property shall be responsible for complying with the Governor's Executive Order that directs all restaurants and bars providing outdoor service shall assure that all customers are seated at tables, table size is limited to a maximum of eight (8) people from a maximum of two (2) households, and tables are spaced a minimum of six (6) feet apart, along with any subsequent amendments to that order.
- 4. The Marshall County Emergency Management Director shall direct the Marshall County Office of Emergency Management to provide such assistance as can be delivered from available local resources and shall coordinate all agencies of local government to provide assistance to the County of Marshall.
- All agencies of Marshall County shall cooperate to the fullest extent with the Marshall County Emergency Management Office and shall provide such assistance as may be required for response to this Emergency Executive Order.
- 6. Under this Emergency Executive Order, as provided in KRS 39A.100(2) the County Judge/Executive can waive procedures and formalities otherwise required by the law pertaining to: a) performance of public work, b) entering into contracts, c) incurring obligations, d) employment of permanent and temporary workers, e) utilization of volunteer workers, f) rental of equipment, g) appropriation and expenditure of public funds.
