I. GUESTS

A. Christy Ramage and Susan Jackson with the West Kentucky Educational Cooperative addressed the court regarding the various programs and services they offer. They are in need of a permanent space to host their adult education students. The WKEC would like to lease the Draffenville Community Building. A motion was made by Com. Lamb and seconded by Com. Spraggs to move forward with a lease agreement between the Marshall County Fiscal Court and West Kentucky Educational Cooperative for the property at 242 Griggstown Road. All voted aye.
