RE: Rivercrest Engineering - Professional Services Agreement Renewal

Judge Neal:

When we established our Rivercrest Engineering Inc. – Marshall County Fiscal Court Professional Services Agreement in March of 2016, the initial term was established to be a renewable two (2) year period. The agreement language in paragraph 1.01.A stipulates, "The term of this Agreement is two years. Thereafter, the Agreement can be renewed annually on its anniversary indefinitely, with unit price fee adjustments negotiated during the renewal process." Our hourly fee structure has not been adjusted since entering into the engineering services agreement with the Court in 2016. For this next proposed one-year renewal period, Rivercrest is requesting the Court consider adjusting our unit price fee structure in accordance with the attached hourly rate sheet. This will likely not have much, if any, of an overall fee impact, as Rivercrest generally performs services for the fiscal court under an agreed upon lump sum fee structure. We know of no other Agreement modifications or language updates that are warranted at this time.

If the Fiscal Court is agreeable to extending our Professional Services Agreement, we suggest an extension to May 19, 2022. Our signatures below will suffice for our renewal purposes. If the Fiscal Court needs additional documentation or prefers to draft a letter authorizing this Agreement renewal, that will be fine with us as well.
