- Majority of increase resulted from increases reported on the statements of value
 - Sheriff's Officers up 58% & Other Officers up 30%
- Safety committee discount = \$3,094

Work Comp:

- Rates fell overall 2%, but payroll increased \$249,000
- Mod increased to 1.09 from 1.09
- Safety committee & drug free workplace discount = \$21,536
 - Between safety/DFW discounts and other credits, the mod increase was offset entirely
 - Increase was entirely payroll related
