

Marshall County Fiscal Court
Special Called Meeting
September 21, 2021

The Marshall County Fiscal Court met for a Regular Meeting on Tuesday, September 7, 2021 at the Marshall County Courthouse, Benton, Kentucky. Elected Commissioners: Justin Lamb, Kevin Spraggs, Monti Collins, County Attorney Jason Darnall were present. Judge Neal presided.

Judge Neal called court to order at 9:39 A.M.

I. GUESTS

A. Leonard Harp with the Marshall County Veterans updated the court on the number of trips they have made taking Veteran's to appointments including miles, hours, number of clients served, and volunteer drivers.

B. Marshall County Library Director Tammy Blackwell updated the court on strategic planning, tax rates, outreach, and new programs they have initiated due to Covid restrictions.

Lamb to approve paying CMS Architects up to \$72,255.18 pending verification of the A&E fee amount using funds from the Edward Jones Investment account. All voted aye. Motion carried.
