# Marshall County Fiscal Court January 18, 2022

The Marshall County Fiscal Court met for a Regular Meeting on Tuesday, January 18, 2022 at the Marshall County Courthouse, Benton, Kentucky. Elected Commissioners: Justin Lamb, Kevin Spraggs, Monti Collins, County Attorney Jason Darnall were present. Judge Neal presided.

Judge Neal called court to order at 9:38 A.M.

## GUESTS

- A. Leonard Harp with the Marshall County Veterans Support Group updated the court with the year-end totals for the vans. In 2021, they provided 202 trips, totaling 705 hours and 22,949 miles assisting Veteran's in need of transportation to various appointments in the region.
- B. Laurel Matula with ER Assist provided a county update on disaster clean up. To date, debris cleanup is approximately 50% completed and consists of 222,810 cubic yards of natural debris. EM Assist is currently collecting documentation on all volunteer hours so those can be used to apply for additional FEMA grants.
