Save Our West Kentucky Lakes and Rivers

The western Kentucky area of the Jackson Purchase and adjoining counties are a recreation and water resource treasure. Consisting of two massive lakes, Kentucky and Barkley with LBL, four of the largest rivers, Cumberland, Tennessee, Ohio, and Mississippi, this area is truly unique in the entire world. This area is threatened by the invasive fish "Asian Carp" which if left unchecked destroys natural biodiversity and recreational enjoyment.

The 11 counties of Ballard, Carlisle, Calloway, Fulton, Graves, Hickman, Livingston, Lyon, Marshall, McCracken, and Trigg have joined together to create the Save Our West Kentucky Lakes and Rivers taskforce. The taskforce is seeking both Federal and State support to create private sector infrastructure that will provide a long term solution for the problem. Utilizing limited initial government funding, along with private sector investment will allow creation of a commercial industry that is competitive with other non-fish based products. Asian Carp are in many parts of the world a major food resource and industry. (billions of dollars in China alone). To date existing area efforts of subsidized harvest with commercial utilization of processed fish is making an impact on their expansion, however it's not enough. The market value of finished carp products is not sufficient for expanding the harvest level enough for population control.

The Taskforce recognizing this limitation and with discussions with the commercial industry proposes a local economic development program for each county that enhances the existing ED tool box in attracting new fish based processing infrastructure. Local County Capital support through grants and low interest loans will create a thriving, sustainable commercial Carp industry for Western Kentucky. In Ballard County alone there are seven companies in various stages of development and Marshall County just announced a new Carp processing plant which will create infrastructure for processing Asian Carp. State funding under this request will allow these projects to be successful and expansion of similar projects in the other 9 counties can occur.

The taskforce requested and received an initial legislative appropriation of \$2 million dollars for the taskforce to utilize as start-up funds, leading to the creation of this new industry. It has been suggested we look at additional Federal and State funding sources of these funds be from the ARRA, USDA, EPA, and other federal funds allocated to address this **National Problem**. These funds should be designated for uses that will address the invasive fish issue and will create jobs and expanded economic development for the 11 county area.

The taskforce stands ready through the Fiscal Courts administration of the funds and the counties economic development organizations implementation of the funding to be the vanguard that keeps this invasive fish from expanding throughout the Commonwealth and the horrible consequences to recreation and biodiversity for all Commonwealth water resources.
