Marshall County Fiscal Court June 7, 2022

The Marshall County Fiscal Court met for a regular meeting on Tuesday, June 7, 2022 at the Marshall County Courthouse, Benton, Kentucky. Elected Commissioners: Justin Lamb, Kevin Spraggs, Monti Collins, County Attorney Jason Darnall were present. Judge Neal presided.

Judge Neal called court to order at 9:37 A.M.

I. GUESTS

- A. Deputy Judge Brad Warning read the bid advertisement for heart monitors that was published in the May 12th edition of the Tribune Courier. One bid was received and reviewed by EMS Director Bryan Cutsinger. A motion was made by Com. Lamb and seconded by Com. Spraggs to accept the bid from Stryker for the heart monitors for \$71,615.85. All voted aye. Motion carried.
- B. Marshall County Sanitation Chairman Randy Green updated the court on the repairs needed on the Sanitation line along Highway 641. The pump for that area has failed and a new lift station needs to be installed. The new pump will be a temporary fix and should be arriving soon. A motion was made by Judge Neal and seconded by Com. Collins to approve the purchase and installation of the lift station for \$125,000 with funds to come from investments. Com. Spraggs requested the District advertise for bids for the lift station. County Attorney Jason Darnall stated that this issue does meet the requirements as an emergency. All voted aye. Motion carried.
- C. Marshall County Coroner Michael Gordon addressed the court requesting an increase in the line to fund pauper burials and some of the issues regarding the responsibility for those invoices. \$100 from the Coroner's supply line will be moved to the pauper burial line in the appropriation transfer.
