The Marshall County Fiscal Court met for a regular meeting on Tuesday, June 21, 2022 at the Marshall County Courthouse, Benton, Kentucky. Elected Commissioners: Justin Lamb, Kevin Spraggs, Monti Collins, County Attorney Jason Darnall were present. Judge Neal presided.

Judge Neal called court to order at 9:37 A.M.

I. GUESTS

A. Parks Director Britney Hargrove updated the court on fundraising efforts for the Miracle League and the grants for the tennis clinics. Ms. Hargrove also presented the quotes for replacing the dock at Rocky Point Day Use Park. SAFE funds can be used to pay for the replacement, as this dock was the main location used by Living Lands and Water to offload tornado debris from the lake. A motion was made by Com. Collins and seconded by Com. Lamb to completely replace the dock. All voted aye. Motion carried. A motion was made by Com. Collins and seconded by Com. Lamb to advertise for bids for replacing the Rocky Point dock. All voted aye. Motion carried.
