The Marshall County Fiscal Court met for a Special Called meeting on Tuesday, December 6, 2022 at the Marshall County Courthouse, Benton, Kentucky. Elected Commissioners Justin Lamb, Kevin Spraggs, and County Attorney Jason Darnall were present. Commissioner Monti Collins was present via zoom. Judge Neal presided.

Judge Neal called court to order at 8:30 A.M.

I. GUESTS

A. Chad McCann with Rivercrest Engineering presented the bids for the installation portion of the Hardin water project. Three bids were received. Rivercrest recommends accepting the bid from Murtco. A motion was made by Com. Spraggs and seconded by Com. Lamb to accept the bid from Murtco for the Hardin Water Project for \$324,995. All voted aye. Motion carried.

D. Treasurer Erica West read Ordinance 2022-10 Budget Amendment, first reading.


