General terms and conditions

The following is a contract between Ritchie Clint Smith; for Thunder in the Sky Pyrotechnics(TSP) to provide a pyrotechnic display for City of Benton Kentucky and Marshall County Fiscal Court on March 30th 2024 at HH Lovett park in the amount of \$ 8,500, and will last for approximately 14 to 16 minutes. TSP will provide all necessary fireworks for the display, all required equipment needed to fire the display, any permits required, and the skilled and trained operators to set up and shoot the display. The display will be fired electronically.

TSP will provide cleanup of the immediate discharge area following the display and safely dispose of any "left over" fireworks devices properly.

Cancellation policy

The cancellation policy will be handled on a case by case basis. City of Benton Kentucky and Marshall County Fiscal Court has the right to cancel the fireworks display due to unfavorable conditions if it is absolutely necessary. If the fireworks display is cancelled after 8:00 AM on the day of the show, then a fee of 50% of the total show cost, (cancellation fee) will be payable to TSP within 30 days of the day of the originally scheduled event. If the fireworks display is cancelled and rescheduled for the original contract

Insurance coverage, liability, and regulatory section

TSP will maintain General Liability insurance during set up, display and clean up utilizing the most recent edition of ISO CG0001 or its equivalent, insuring against bodily injury, property damage and contractual liability with limits of no less than \$1,000,000 per occurrence and \$2,000,000 annual aggregate. The liability policies shall name the City of Benton Kentucky and Marshall County Fiscal Court as an additional insured and shall be endorsed to include a Waiver of Subrogation in favor of each. TSP will provide documentation as proof of insurance coverage once this contract has been accepted. TSP will work directly with the Authority Having Jurisdiction in conjunction with the Commonwealth of Kentucky for all applicable permits and abide by all regulations by local, state, or federal entities in regards to fireworks displays, storage, handling, and transportation. TSP employees are well trained competent operators and are experienced in the proper use of fireworks and other pyrotechnic devices.

Payment terms

50 % Deposit requested when Contract is signed and mailed back City of Benton Kentucky and Marshall County Fiscal Court will pay the full contract amount on the day of the show. The check should be made to Thunder in the sky pyrotechnics LLC If there is any cancellation of the show due to unfavorable conditions, TSP will produce an invoice and request payment within 30 days of the invoice date.
